#### **CLARIFICATIONS TO THE REQUEST FOR PROPOSAL:**

**BID DATE:** Remains the same – September 25<sup>th</sup>, 2024 at 2pm.

SUBSTANTIAL COMPLETION DATE: Date for work remains the same: August 23rd, 2025

Proposals must be completed in both words and figures on forms furnished by the College, or on previously-approved, substantially-identical forms generated by computer software, which shall be submitted electronically in an e-mail titled: "Bid for: WMC24-03White Mountains Community College Library Roof Replacement" received by MATTHEW MOORE at <a href="memoore@ccsnh.edu">memoore@ccsnh.edu</a> as specified no later than 2:00 PM, September 25<sup>th</sup>, 2024.

Question #1: Clarification on a coverboard.

Answer: System A and A1: Provide top layer of 1-1/2" polyisocyanurate with a layer of ½" high density polyisocyanurate cover board or a 2" composite polyisocyanurate and high-density cover board at the bidder's option to maintain the 30-year total system warranty. The remainder of the system remains and installation method remains the same only the top 2" layer of insulation material is revised. The intent is to provide 30-year total system warranty.

Question #2: I don't see a bid line for A1 (alternate) on the bid form. Answer: Revised Bid Form attached.

Acknowledge receipt of this Addendum with the Proposal Form. Failure to do so may disqualify the Bidder.
